

**KENNISGEWING : KORTING OP EIENDOMSBELASTING –
EIENDOMME GEREISTREER AS LANDELIK**

Kennis geskied hiermee dat die Kannaland Munisipaliteit op 18 Maart 2019 die volgende Raadsbesluit geneem het:

COUNCIL 27/03/19 – INSAKE LANDBOU-BELASING: MERIETE KORTING

BESLUIT:

1. Dat die Raad goedkeuring verleen vir die meriete korting van 35% op die aanvanklike heffingsbedrag vir 2016/17, 2017/18 en 2018/19
2. Dat alle rentes en boetes ten opsigte van punt 1 hierbo, afgeskryf word indien persone rekeninge ten volle voor einde 30 Junie 2019 betaal.
3. Dat 'n verdere 10 persent op heffingsbedrag toegestaan word op aanvanklike heffing indien volle betaling voor of op 15 April 2019 geskied of 'n verdere 5% korting indien voor of op 15 Mei 2019
4. Persone wie nie gebruik gemaak het van die Amnestie proses nie, sal 35% ontvang op heffings (vir die boekjare wat van toepassing was). Mag ook aansoek doen om rente afskrywing onderworpe aan betaling van rekeninge voor einde Junie 2019
5. Derhalwe mag landbou eienaars wie resorteer onder punt 4 hierbo, ook kwalifiseer vir verdere kortings soos uiteengesit in punt 3 met dien verstande dat sperdatums streng nagekom word.
6. Persone wie alreeds hul rekeninge betaal het sal krediete teen hul lopende rekeninge ontvang wat teen toekomstige heffings aangewend sal word maar geen kontant terugbetalings sal toegelaat word nie.
7. Dat die Landbouverenigings bedank word vir hul goeie gesindheid ter bevordering van onderlinge verhoudinge tussen twee partye.
8. Dat verdere kortings sal geskied op grond van amptelike afkondigings (Droogte Proklamasie in die Staatskoerant) en die betrokke beleidsvoorwaardes en bepalinge.

**HIGHLY IMPORTANT NOTICE: DISCOUNT ON PROPERTY RATES – PROPERTIES
REGISTERED AS RURAL**

Highly important notice is hereby given that Kannaland Municipality took the following council resolution on 18 March 2019:

COUNCIL 27/03/19 – REGARDING RURAL PROPERTY RATES: CONDITIONAL DISCOUNT

DECISION:

1. That Council grants permission for a 35% conditional discount on the original rates levies for the financial years 2016/17, 2017/18 & 2018/19
2. That all interest and penalties in respect of 1 above be written off on condition that the full amount be paid not later than 30 June 2019.
3. That an additional 10% on the levy amount be granted if the full amount is paid by not later than 15 April 2019 or an additional 5% if paid in full by not later than 15 May 2019.
4. Account holders who did not take part in the previous Amnesty process will qualify for a 35% discount in respect of the applicable financial years. Application may be submitted for writing-off of interest and penalties on the condition that the full amount is paid by no later than 30 June 2019.
5. Account holders as per paragraph 4 above, will also qualify for the discounts in paragraph 3 above on the condition that all due dates are met.
6. Accounts already paid in full will receive credits on their current accounts which will be applied against future levies. No cash pay outs will be allowed.
7. Council wish to thank the agricultural society for their role to build better relations between the parties
8. Any further discounts (Drought) will be granted based on an official publication in the Government Gazette and in line with the applicable policies.
