#### WARD COMMITTEE MEMBER NOMINATIONS: 2021 – 2026 TERM FOR ALL WARDS



The following criteria apply and will render the nomination valid and credible if:-

- The nominee is registered on the municipal Voter's Roll in the ward for which he or she is nominated;

- The nominee is not a Municipal Councillor;
- The nominee is not employed by the Municipality;
- The nominee does not have one or more municipal accounts in his/her name which has been outstanding for more than three months since the closing date for nominations.
