NOTICE TO INVITE PUBLIC COMMENTS ON THE DRAFT FINANCIAL RECOVERY PLAN FOR KANNALAND LOCAL MUNICIPALITY REQUIRED IN TERMS OF SECTION 141(3)(C)(ii) OF THE MFMA.

The Western Cape Provincial Executive resolved to intervene in the Kannaland Local Municipality in accordance with the requirements of section 139(5)(a) of the Constitution of Republic of South Africa, 1996 read with section 143 of the Local Government: Municipal Finance Management Act, 2003 (Act No. 56 of 2003) to respond to a financial crisis and persistent failures in the provision of basic services in the Municipality.

The Mandatory Financial Recovery Plan (FRP) was prepared by the National Treasury Municipal Financial Recovery Service. In line with the requirements of Section 142 of the MFMA, the Mandatory FRP has been designed for use as an instrument to secure the Municipality's ability to meet its obligations to provide basic services and its financial commitments, and to place the Municipality in a sound and sustainable financial condition as soon as possible.

The FRP was prepared for the Municipality in accordance with the requirements set out in section 144, read with section 141, of the MFMA.

This notice serves to invite the public, including the local community, in terms of section 141(3)(c)(ii) of the MFMA to submit written comments in respect of the draft FRP within fourteen (14) days from date of publication of this notice.
