EXTERNAL MUNICIPAL BURSARY PROGRAMME 2023

Applications are hereby invited from students who are currently in Grade 12 and learners who already have passed grade 12, for financial support for further studies in the 2023 academic year. The award is limited to full-time studies at an accredited tertiary institution. Students must reside within the Greater Kannaland Municipality including the rural areas. Bursaries for approved students will be paid directly to the institution on receivable proof of registration.

The aim of this program is to develop students and learners with potential and performing learners within the Municipality's municipal area, affording partiality to individuals from historically disadvantaged societal groups and individuals with disabilities.

Bursaries will be allocated for a period of three (3) years to allow students to undertake a full time Graduate Degree or Diploma. Students who applied for and are receiving bursaries from NSFAS can't apply. Application forms are available at all municipal offices, during normal work hours (07:30-16:00).
