### **T1.1 TENDER NOTICE AND INVITATION TO TENDER**

Kannaland Municipality invites tenders for the upgrading of various street and sportsfield lighting installations at Green Hills, Van Wyksdorp and at Calitzdorp Sportsfield.

It is estimated that tenderers should have a CIDB contractor grading designation of 3EP or higher.

Preferences are offered to tenderers who tender in accordance with the Preferential Procurement Regulations, 2017.

Only tenderers who are in possession of a valid Tax Clearance certificate as well as a B-BBEE scorecard are eligible to submit tenders.

Tenderers must be registered on the Kannaland Municipality's Supplier Database and Central Supplier Database ( SD).

Tenderers who are not registered on the Kannaland Municipality's Supplier Database and the Central Supplier Database (CSD) are not precluded from submitting tenders, but must however be registered prior to the evaluation of their tenders in order for their tenders to be responsive.
